The following specifications are for MAC files only. PC files are acceptable if they follow specifications.

FULL PAGE AD WITH BLEED

8.5" w x 11" h TRIM SIZE
(Please make sure your artwork extends atleast 1/8 of an inch outside of the trim size all the way around)

7.75" w x 10.25" h LIVE AREA

8.75" w x 11.25" h BLEED SIZE

FULL PAGE AD WITHOUT BLEED

7.75" w x 10.25" h AD SIZE

Half Page Color Ad

APPLICATIONS ACCEPTED

Adobe Acrobat 8.0 (high resolution PDF, embed all fonts) *preferred**
Please offset your crop marks by .167.

Photoshop CS3 (saved as TIFF or EPS)

GRAPHICS

Line art must be at least 1200 dpi and photos should be 300 dpi or higher. We will not be responsible for the reproduction of graphic elements that do not meet these requirements and will reject unacceptable quality.

FONTS

Please convert fonts into outlines if submitting an ad created from Adobe Illustrator or another vector program. Otherwise, you must embed the fonts into your document and include fonts embedded in graphics files when you submit your file - TrueType fonts for PC files.

COLORS

Convert all EPS and TIFF files to CMYK before placing in final document. Please convert spot colors to CMYK also. We accept color ads only for the Show Guides.

COMPRESSING FILES

StuffIt or Zip compressed files accepted. Self-extracting files preferred.
